Mission: Advocating for a healthy, equitable, and balanced relationship between the built and natural environments.

Vision: We envision a beautiful and environmentally sustainable county.

Summary: Established as a 501c3 non-profit in June of 1968, Champaign County Design and Conservation Foundation (CCDC) is the oldest environmental conservation organization in the county. Its first major project can be traced to the late 60s/early 70s when Dutch elm disease decimated the local American elm tree population in Champaign County and across eastern North America. CCDC raised funds and worked with local governments to plant trees and restore the devastated urban forest canopy. Two more recent notable projects carried out by CCDC include the rail-banking and lease of the CSX rail corridor, now developed as the Kickapoo Rail Trail, and the financial backing that led to the development of the Red Oak Rain Garden, located near McKinley Health Center and Allen Hall on the University of Illinois campus.

In 2022, the CCDC board of directors embarked on a year-long facilitated effort to update its strategic plan. The following document is the result of that effort and will serve as a road map to guide its goals and commitment to action over the next several years. As it has over its long and highly successful history, CCDC will continue to partner with the Champaign County community to advance environmental justice, promote clean air and water, and foster healthy communities. To put it more succinctly, CCDC will support trees, trails, and a robust network of environmental stewards.
